



To be voted on and approved by the members of the North Carolina Medical Group Managers ("NCMGM") in accordance with the applicable provisions of the Organization's Bylaws, as amended (the "Bylaws"), at the September 27, 2024, meeting held in Winston Salem, North Carolina:

**Motion to form Carolinas MGMA:** We move that NCMGM proceed with all actions necessary for combining with the South Carolina Medical Group Managers Association ("SCMGMA") to create the Carolinas Medical Group Managers Association ("Carolinas MGMA"), effective January 1, 2025. This motion is subject to both parties coming to mutually agreeable terms set forth in appropriate documents to be signed by the parties.

**Further Actions:** We move to approve that the Board and officers of NCMGM be authorized and empowered to take any and all additional actions necessary, desirable, or expedient in order to carry out the integration of both NCMGA and SCMGMA to form Carolinas MGMA.
