NCMGMA, NCMS and Curi continue working together to gather essential practice information from administrators and clinicians across North Carolina relative to the current COVID-19 crisis. The week of January 18, 2021, our practice survey included questions on the COVID-19 vaccination. The following is a summary of those results.

Percentage of responding practices with 10 or fewer physicians


Percentage of the practices surveyed that are independently owned.

43%.....Access to vaccine for patients


15%..... Keeping up with new science/data


24%.....Enrolling as vaccine provider or navigating in CVMS

What percentage of your staff has received the vaccine?









What percentage of your staff has indicated that they will receive the COVID-19 vaccine?



- 82% of responding practices said they had been in touch with the local county health department for information on getting staff vaccinated.
- 86% of responding practices said they had the necessary information about where in the vaccination prioritization staff and patients are and when they can receive the vaccine.

Incentivizing Vaccinations

Listed incentives include:

- Two extra paid days off;
- Pins and t-shirts;
- Time off to get the vaccine;
- Vaccine bonus.

One practice noted that they are asking staff who refuse to get the vaccine to sign a waiver.



Who wants to be a vaccine site?

Primary Care Practices (those identifying themselves as family practice, internal medicine, pediatric, primary care, multi-specialty and ob-gyn) represented a full **90%** of practices indicating they want to be a vaccine site despite only representing **61%** of all responding practices.

Other insights of note:

- Only one-third (32%) of all practices have contacted their local health department regarding helping to provide vaccines to patients.
- Almost a quarter (24%) of practices saying they wanted to be a vaccine site had not yet reached out to their local health department.
